The eyesight certificate must be from a nationally registered doctor for near vision, permitting reading a minimum of Times Roman N4 or equivalent letters at not less than 300 mm on a standard test chart for near vision, in at least one eye, corrected or uncorrected. Candidates for the Coating Inspector examinations are also required to have had a colour perception assessment by the Ishihara 24 plate test or an equivalent.
